C.2.3 DIVISIONS

Amend to read:

- (a) Age / Gender Divisions in World and Continental events
Ages are identified as from the 31st December in the year of the competition
 - i. U13 Division: boy or girl under the age of 13 years old
 - ii. U17 Division: boy or girl under the age of 17 years old

- (a) Age / Gender Divisions in World and Continental events
Ages are identified as from the 31st December in the year of the competition
 - i. U12 Division: boy or girl under the age of 12 years old
 - ii. U15 Division: boy or girl under the age of 15 years old
 - iii. U17 Divisions: boy or girl under the age of 17 years old

Amendment Three

C.2.3 DIVISIONS

Amend to read:

(c) The U13 Division and U17 Division shall use the 4.5 sqm **sail** as supplied by a licenced manufacturer. The Notice of Race may specify the use of the 3.8 sqm **sail** as supplied by a licenced manufacturer

(c) The U12 Division shall use the Dacron 3.5 sqm **sail** and the U15 and U17 Division shall use the Monofilm 4.5 sqm **sail** as supplied by a licenced manufacturer. The Notice of Race may specify the use of the Monofilm 4.5 sqm as supplied by a licenced manufacturer for the U12 Division. In a transition period until 30 July 2022 the Notice of Race may specify the use of the deprecated 3.8 sqm **sail** for the U12 Division as supplied by a licenced manufacturer.

(a) IDENTIFICATION

Sail numbers shall comply with the RRS except where prescribed otherwise in these **class rules**.

- (i) The numbers shall be placed within the 2nd sail panel from the bottom of the **sail** both sides (starboard higher), in accordance with RRS appendix G1.3.
